US intelligence agencies concluded with "high confidence" last year, in an unclassified intelligence assessment, that the Kremlin shared hacked emails with WikiLeaks that undermined Hillary Clinton's presidential campaign as part of its effort to sway the 2016 election in favour of Donald Trump.

Waldman is a lawyer and consultant in Washington and Deripaska's primary lobbyist. He also represents other clients including Hollywood stars. Last year Deripaska paid Waldman about \$562,000. According to filings to the Department of Justice (DoJ) by Waldman's firm, the Endeavor Group, his

Waldman has not registered himself as a lobbyist for the WikiLeaks founder.

A report last year by Fox News, which obtained leaked text messages between Waldman and the US senator Mark Warner, the top Democrat on the Senate intelligence committee, suggested Waldman tried to broker a deal between Assange and the DoJ and that the negotiations were fruitless. It is not clear whether Waldman was brokering the deal on Assange's behalf or someone else's.

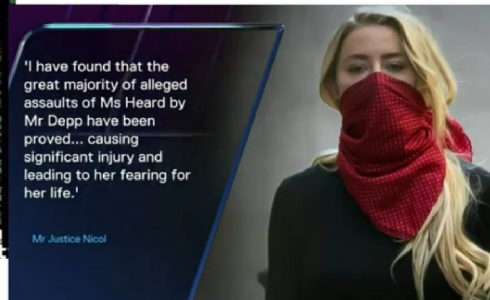
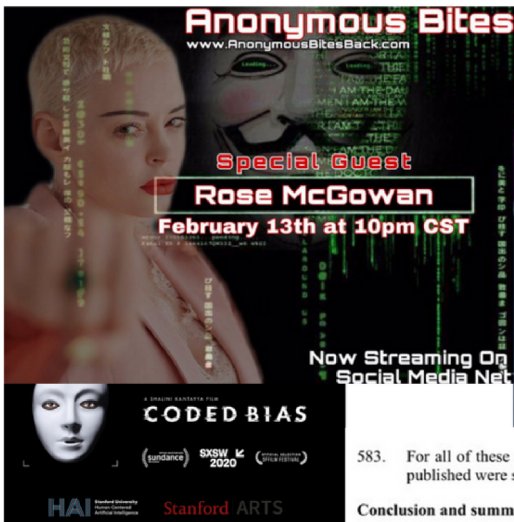

583. For all of these reasons I accept that the Defendants have shown that the words they published were substantially true in the meanings I have held them to bear.

**Conclusion and summary**

584. It follows that this claim is dismissed.

585. The Claimant has not succeeded in his action for libel. Although he has proved the necessary elements of his cause of action in libel, the Defendants have shown that what they published in the meaning which I have held the words to bear was substantially true. I have reached these conclusions having examined in detail the 14 incidents on which the Defendants rely as well as the overarching considerations which the Claimant submitted I should take into account. In those circumstances, Parliament has said that a defendant has a complete defence. It has not been necessary to consider the fairness of the article or the defendants' 'malice' because those are immaterial to the statutory defence of truth. The parties will have an opportunity to make submissions in writing as to the precise terms of the order which should follow my decision.

The story is based on allegations made in a report compiled by experts for Amber Heard's lawyers earlier this year and seen by The Times.

The lawyers asked the experts to investigate whether Ms Heard had been a victim of "an ongoing targeted harassment and smear campaign, and if Johnny Depp or [his] associates are responsible ..."

The report claims to have "identified 13 active inauthentic accounts recently created specifically to target the Twitter account of Ms Heard. We also identified an additional 22 inauthentic accounts that became inactive

Heard. We also identified an additional 22 inauthentic accounts that became inactive shortly after attacking Ms. Heard. Approximately 1.7% of the accounts we analyzed were inauthentic, and if we extrapolate that number, we estimate 340 of the 20,000 accounts tweeting about Ms. Heard were inauthentic accounts".

The report goes on to highlight that "inauthentic" Twitter accounts had been "sharing links" to two separate [Change.org](#) petitions. One is calling for DC Entertainment to remove Ms Heard from Aquaman 2, and the second petition is demanding L'Oréal remove here as their spokeswoman.

The report says: "We noted the suspicious timing and strange activity associated with the petitions, and [Ms Heard's lawyers] requested we investigate the activity further.

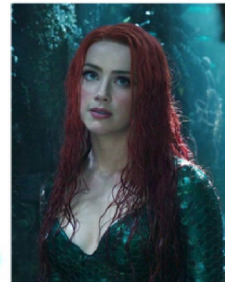
"While monitoring the Remove Amber Heard from Aquaman 2 petition, we observed a significant number of fraudulent signatures, and we estimate 1 out of every 3 signatures were conspicuously fake or highly suspicious".

**THE judge today ruled Depp attacked his ex-wife 12 times in their relationship. These were:**

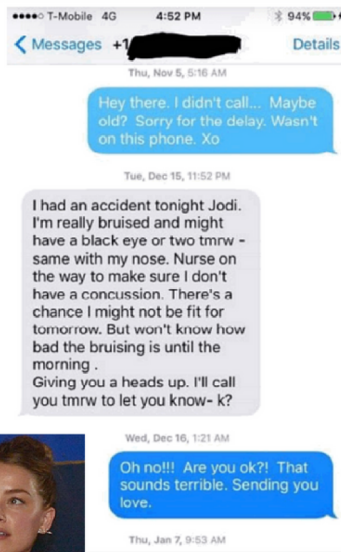
1. In early 2013, Depp slapped and knocked Heard to the ground after she made a joke about his "Wino Forever" tattoo
  2. In March 2013, the actor flew into a rage while high on drugs and hit Amber so hard he made her lip bleed
  3. In June 2013, Depp attacked Amber in a trailer in Hicksville - throwing glasses at her and ripping her dress
  4. In May 2014, the actor screams at his wife on a private jet after taking drugs and boozing before kicking her in the back or bum
  5. In 2014, Depp grabs Amber by the hair, slaps her and pushes her to the ground on a detox trip to the Bahamas.
  6. In January 2015, the star again attacks Amber while on drugs - this time slapping her and pushing her to the ground. He then forced her tears as he stood over her yelling.
  7. In March 2015, Depp launches into a brutal three-day attack in Australia - leaving Heard with a broken lip, swollen nose and cuts all over her body. He trashed the house in the violent rampage and pushed Amber to the ground, shaking her and
- A. Additionally, she had a very swollen nose at that point that was quite tender, and maybe another scalp or hair laceration or scrape on the front of her scalp as well, and like an injury to her lip.

They are among the most loyal and shrill on Twitter. They heap praise on the actor, eviscerate anyone associated with Heard, and have posted exclusive audio recordings of the couple fighting (albeit edited in a way that favors the actor). But many who have battled Depp question whether the army is real or high-end bots. Kaplan believes it's a combination of the two, with bots amplifying what real fans post.

"My firm is involved in a lot of controversial cases," she says. "Our clients are suing the white supremacists and neo-Nazis responsible for the violence in Charlottesville. I have clients who are suing Donald Trump. But, by far, the one case [of ours] that has generated the greatest amount of hostile social media attacks is Johnny Depp v. Amber Heard. Not even close."

Heard received vindication in November when trial judge Mr Justice Nicol accepted that "the great majority of alleged assaults of Ms Heard by Mr Depp have been proved" to the standard required by Britain's civil courts.

Robinson cannot talk about Heard's case for legal reasons — the actor still faces a \$50m defamation lawsuit brought by Depp in the US — but says Heard's statement outside court "gave an insight into what it was like for her to be forced to come and speak about some of the most traumatic experiences of her life," she says. "Amber is one of the most intelligent, hard-working women I have ever met.

"It was a sad reflection to me on our society that a woman who has made domestic violence allegations would require security to come in and out of court," she adds. "We had people bang on the window of the car as we came through the secure entrance — they would shout at Amber and call her a liar and a gold-digger."

Depp: I cannot account for what is or is not in the witness statement that was prepared.

Depp: Yes, this is a text that I forgot to hit send on and I am apologising for in any way upsetting him, upsetting Paige, upsetting Amber.

No -- one cannot fly with one wing, so in every argument there are two involved. One can escalate the situation or one can de-escalate the situation. And it just depends on the moment, and I, again, I was being as honest with Mr. Heard as I can be. Never do I say "I have punched or hit or smacked or hurled your daughter across the room", or anything of that nature.

Wass: You also never say anywhere, "I did injure her by accident, by headbutting her, I was trying to calm her down".

Depp: No, I did not say that. I, again, the -- no, I did not say that.

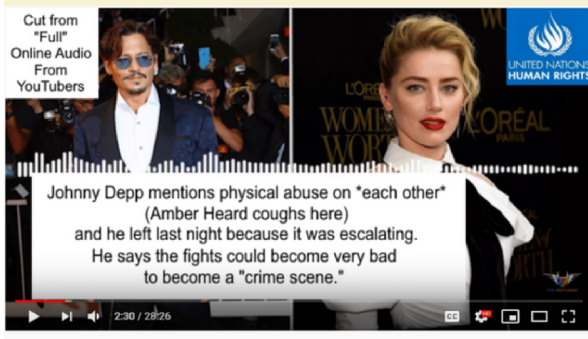

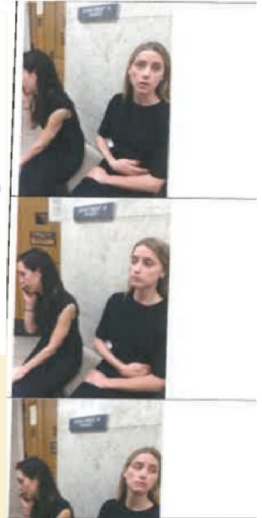

News Group is trying to compel the testimony of makeup artist Mélanie Inglessis, who, in a 2019 declaration, said she witnessed Heard's bruised face and cut lip and helped to hide the injuries for an appearance on *The Late Show With James Corden*. She recalls, "Amber repeatedly told me that she did not want to expose this part of her life to the public, and that she was considering canceling the appearance altogether." Inglessis said she and Heard became close friends after she began working with her in 2015 and that she remembers "numerous" times Heard told her she had been abused.

On May 16, Inglessis filed a motion in California federal court asking Magistrate Judge Patrick J. Walsh to quash his order compelling her give live testimony via a video feed. She also informed the court that she's received "death threats and faced online harassment" despite not making any public comments on the matter.

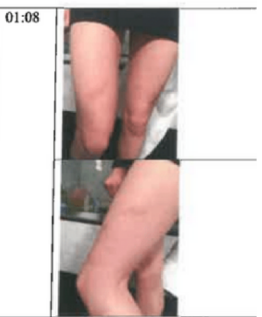
"This case, and the related U.S. case, are high-profile matters involving international celebrities and are receiving intense media scrutiny," writes her attorney Anya Goldstein. "Ms. Inglessis genuinely fears for her safety as it is. If she is forced to testify for NGN, and, by extension, for its controversial tabloid, *The Sun*, the threats and harassment she faces will undoubtedly escalate."

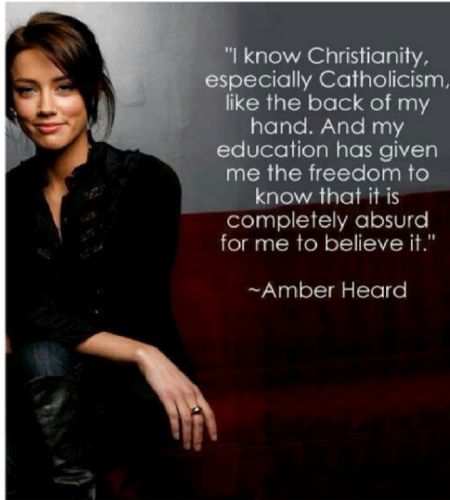
